

2019 GCPRA Sanction Agreement

Other Provisions

The Navajo County Fair Rodeo Committee would like to make some adjustments to your sanction agreement for our rodeo. These changes have helped make our rodeo very successful. Our Rodeo Committee works very hard trying to improve our rodeo and make it the best of the best for the contestant, association, stock contractor and the people who are buying the tickets. As you also know, we ask a lot of the personnel and expect things to be done a certain way. In return, we try to take care of them the best that we can. Thank you GCPRA and your personnel for helping our committee make our rodeo one of the best.

The 2019 rodeo will run in the same format but will have new entertainment. Our rodeo will start at 7:00 p.m. on Friday, September 13, 2019 and at 6:30 p.m. on Saturday, September 14, 2019. We will start on time and we will strive to be done in two and a half hours. We will keep you informed as things come together throughout the year. We are looking forward to working with you this year. If you have any questions, please call.

Local & CES Contestant Entries

- The Rodeo Committee will have the right to allow 30% local entries per performance (3 in an event where 10 are allowed) **except** in Bull Riding as that will be 50% for Bull Riding local entries (that will be 10 in bull riding as we have 2 rounds of Bull Riding in each rodeo performance and 3 in Barrel Racing where 10 are allowed). Ground must be raked after 5 each performance and during slack.
- There will be no more than 10 entries per event, except in rough stock events – firm on this
- All performances must be full in each event before we will have slack
- Local entries are **100 mile radius** to include the reservation and our county
- If an event is not FULL at the time the stock is drawn, we ask that you draw extras so if a contestant shows up late, they can pay fees and be assigned an animal (this only pertains to rough stock)
- GCPRA Rule will be followed

Co-Sanctions

We would like to be co-sanctioned with all of the following: NMRA (New Mexico), CPRA (Colorado), AIRCA (All Indian), CNRA (Central Navajo Rodeo Association)

Slack

All team roping will be held on Friday, September 13, 2019, at 8:00 a.m. Absolutely no one in the arena at any time unless competing and we mean ANY TIME! All ropers will exit from bottom of the arena. There will be second round of slack on Saturday, September 14, 2019, at 8:00 a.m.

Awards

We will be adding \$1000 in all main events except for Bareback and Saddle Bronc, we will be adding \$1,500 and team roping which will be \$2,000 (\$1,000 per man). In the Incentive Calf Roping and Incentive Barrel Racing we will be adding \$600 per event, except for Incentive Team Roping we will be adding \$1,200 (\$600 per man). Buckles will be given to each average champion in all events. As an

added award we will be giving a vest to the performance winner in each event for Friday and Saturday night performance.

Order of Events will be as follows:

- Bareback
- Calf roping
- Breakaway
- Saddle bronc
- Steer wrestling
- Barrels
- 1st bulls
- 2nd bulls.

Arena Rules

- As you know, this rodeo will have a closed arena. All contestants enter from behind the box. The only exception is if it is a safety issue and the judge makes the call.
- No one enters this arena unless the Arena Director or a judge says so. It is a safety concern. As you know, we have a lot going on at once. The rule also goes for in front of the bucking chutes. If they don't have an official shirt on they need to get out.
- Please enforce the 3 call rule.

In-Kind Services

- Warm-Up Arena – we will have a warm up arena available at all times, including slack
- There will be a horseshoer on the grounds at all times.
- There will be a veterinarian on the grounds at all times.
- We are asking for mailing labels and/or email addresses of each of your members at least one (1) month in advance as we will mail/email out a welcome letter to each of them for this rodeo
